Ansys Store Terms of Use

Acceptance of the Terms of Use

These terms of use are entered into by and between You (as defined below) and Ansys, Inc. ("Ansys," "we," or "us"). The following terms and conditions ("Terms") govern your access to and use of the Ansys application marketplace, including any content, functionality, and services offered on or through the preceding (the "Ansys Store"), whether as a guest or a registered user. When used herein, "You" or "you" will be understood to mean (i) the person that is accessing the Ansys Store (the "User") and (ii) where applicable, the company or legal entity on whose behalf the User is acting as an employee, consultant, agent, or other personnel (the "Company").

Please read the Terms carefully before you start to use the Ansys Store. By using the Ansys Store or by clicking to accept or agree to the Terms when this option is made available to you, you accept and agree to be bound and abide by these Terms. If you do not want to agree to these Terms, you must not access or use the Ansys Store.

By using the Ansys Store, you represent and warrant that you, as a User, are capable of and authorized to: (i) accept the Terms in your individual capacity as a User, and (ii) where applicable, accept on behalf of and bind your Company to the Terms. If you do not meet the preceding requirements, you must not access or use the Ansys Store.

Changes to the Terms

We may revise and update these Terms from time to time in our sole discretion. All changes are effective immediately when we make them available, and apply to all access to and use of the Ansys Store thereafter.
